# **Accredited Investor Declaration Form**

### **Important Information**

Oanda Asia Pacific Pte. Ltd. ("OAP") is required to provide you with certain information before you make a decision on whether you wish to opt in as an accredited investor. Accordingly, we hereby inform you that:

- (i) You may consent to being treated by OAP as an accredited investor after being informed of the risks and effects of an accredited investor as stated under the General Warning section.
- You may at any time withdraw your consent by writing in to OAP at frontdesk@oanda.com, upon which OAP will not treat you as an accredited investor.
   OAP will require 3 working days upon receipt of the request to process the withdrawal.

### **General Warning**

Accredited investors are assumed to be better informed, and better able to access resources to protect their own interests, and therefore require less regulatory protection. Investors who agree to be treated as accredited investors therefore forgo the benefit of certain regulatory safeguards. For example, issuers of securities are exempted from issuing a full prospectus registered with the Monetary Authority of Singapore in respect of offers that are made only to accredited investors, and intermediaries are exempted from a number of business conduct requirements when dealing with accredited investors. Investors should consult a professional adviser if they do not understand any consequence of being treated as an accredited investor.

#### **Additional Disclosure**

Accredited investors will not be entitled to any compensation made out of the security deposit lodged by OAP with the Monetary Authority of Singapore ("MAS").

## **Accredited Investor Definition**

"Accredited investor" means:-

- (i) An individual:-
  - A. Whose net personal assets exceed SGD 2 million (or its equivalent in foreign currency) or such other amount as the MAS may prescribe;

In determining the net personal assets value, the value of the individual's primary residence is:-

- Calculated by deducting any outstanding amounts in respect of any credit facility that is secured by the residence from the estimated fair market value of the residence; and
- 2) Taken at the lower of the following:
  - a. Value calculated under paragraph (1); or
  - b. SGD 1 million.

- B. Whose financial assets (net of any related liabilities) exceed SGD 1 million (or its equivalent in foreign currency) or such other amount as MAS may prescribe, where "financial assets" means:-
- 1) A deposit as defined in section 4B of the Banking Act;
- 2) An investment product as defined in section 2(1) of the Financial Advisers Act;
- 3) Any other asset as may be prescribed by regulations made under section 341 of the Securities and Futures Act; or
- C. Whose income in the preceding 12 months is not less than \$300,000 (or its equivalent in foreign currency) or such other amount as the Authority may prescribe.
- (ii) A corporation with net assets exceeding SGD 10 million (or its equivalent in foreign currency) or such other amount as the MAS may prescribe, as determined by:-
  - A. The most recent audited balance sheet of the corporation; or
  - B. where the corporation is not required to prepared audited accounts, a balance sheet of the corporation certified by the corporation as giving a true and fair view of the state of affairs of the corporation as of the date of the balance sheet, which date shall be within the preceding 12 months.
